1. **Cllr. T. Barry:** What responsibility does Kerry County Council have to address Health & Safety issues such as lack of street lighting for HAP tenants in privately owned estates? (Details with Directorate) being one such estate.
2. **Cllr. T. Barry:** That some measure will be put in place to deal with the ongoing issue of illegal dumping of rubbish at the rear of the junction box in (Details with Directorate).

(c) Questions

1. **Cllr. J. Lucid:** Can Kerry County Council arrange to have the overgrown hedging/trees at Sliabh a' Mhadra cross where the L 6044-0 joins the L 1032-40 cut back as they completely block the view of traffic coming from Causeway and makes the exit difficult for users.
2. **Cllr. M. Kennelly:** That Kerry County Council open up the area servicing our Kerry County Council Listowel Library as this area is unutilised and serving no purpose

3. **Cllr. M. Kennelly:** That Kerry County Council resolve the lighting situation in (Details with Directorate) as Kerry County Council have houses rented in this area.

1. **Cllr. T. Barry:** Are Kerry County Council responsible for the maintenance of the gates in their housing stock.

5. Operations, Safety & Infrastructure Directorate

(a) To note update report from the Operations, Safety & Infrastructure Directorate.

(b) Notices of Motion

1. **Cllr. J. Moloney:** Can the timing and break between red lights at the traffic lights in The Square be changed? Currently traffic is being held up by red lights that are too frequent.
2. **Cllr. J. Moloney:** Can the members of the Listowel Municipal District be supplied with a schedule of all new public lights planned for 2019.
3. **Cllr. R. Beasley:** That Kerry County Council examine the road from the Men's Shed to Afahona where there is a serious issue with the road sinking in the centre.
4. **Cllr. R. Beasley:** That Kerry County Council seek funding to remove the dangerous bend at Lacey's Cross at the Asdee / Ballylongford Road as it is only a matter of time before a serious accident occurs here.
5. **Cllr. R. Beasley:** That Kerry County Council would take immediate action to prevent the flooding at the rear of St. Patrick's Terrace, Tarbert, which has been reported on many occasions.
6. **Cllr. T. Barry:** That a review of the signage at the junction of Courthouse road and the N69 road in Listowel town be carried out. Due to the large number of vehicles that drive through the stop signs when coming from the Tarbert direction.

7. **Cllr. L. Purtill:** That Kerry County Council would address the footpaths in Asdee. Remove the moss on the Grotto side as it can be dangerous in wet or frosty weather. There is a resident using a walking aid and he is fearful of slipping. There are also some holes on the footpath that need repair.
8. **Cllr. L. Purtill:** That Kerry County Council would address a drainage problem outside the home of (Details with Directorate) Kerry County Council is already aware of the problem.
9. **Cllr. L. Purtill:** That Kerry County Council would address and repair the footpath near the Funeral Home in Tarbert.
10. **Cllr. J. Lucid:** I call on Kerry County Council to intensify their efforts to get Causeway Graveyard extended. Plans have not progressed, and grave capacity is fast reducing.
11. **Cllr. J. Lucid:** I ask the Listowel Municipal District to call on Tralee M.D. to carry out works at Lerrig Cross to alleviate the regular flooding on the bend turning towards Causeway. This matter is urgent as it is a health and safety issue.
12. **Cllr. J. Lucid:** I call on Kerry County Council to ask O.P.W. to make funding available to Kerry County Council to repair the road at Derryco (L-10095-0). This road was damaged when the O.P.W. carried out works on the banks of the river Cashen.
13. **Cllr. J. Lucid:** Will Kerry County Council establish contact with the owners of the property between the Cloisters Estate and the village so that a foot path can be put in place connecting the estate to the Village.
14. **Cllr. M. Kennelly:** That Kerry County Council carry out immediate road works on the Gortaminch Road as recently this road has deteriorated.
15. **Cllr. M. Kennelly:** That Kerry County Council provide more car parking spaces at (Details with Directorate) as parking is a serious issue in this estate.
16. **Cllr. M. Kennelly:** That Kerry County Council carry out safety works at the bridge adjacent to Lisselton Graveyard, Loughanes, Ballydonoghue.
17. **Cllr. M. Kennelly:** That Kerry County Council provide more car parking spaces in Baile O' Dhubha Estate, Listowel as parking in this area has become a serious issue.

(c) Questions

1. **Cllr. J. Moloney:** How many new public lights were erected in the Listowel Municipal District in the last 2 years?

2. Cllr. R. Beasley: What is the update on the Public Toilets in Ballybunion?

3. Cllr. R. Beasley: What is the update in relation to the 2nd phase of the Dale Road?

4. Cllr. J. Lucid: Can Kerry County Council arrange to repair school traffic lights at Sliabh a' Mhadra school immediately. These lights have not worked for a number of years. This is a health and safety issue for 160 pupils, their parents and their teachers.

5. Cllr. J. Lucid: Will Kerry County Council line the car park at Sliabh a' Mhadra primary school so that parking there can be maximised when the school children are being dropped to and collected from School.

6. Cllr. J. Lucid: Will Kerry County Council consider removing the bad bend on the L 1028-10 that is located between Kilflynn Primary school and the Kingdom Structural Steel yard. There are three businesses, a Primary school and Crotta O'Neill's G.A.A. club on the road resulting in heavy traffic.

7. Cllr. M. Kennelly: That Kerry County Council carry out drainage and remedial works adjacent to Lisselton Graveyard, Loughanes, Ballydonoghue.

8. Cllr. M. Kennelly: Can Kerry County Council repair the flashing amber school warning post in Duagh and Collard School entrances as these sign posts are continuously not working and are a serious issue to the parents of the children attending these schools.

9. Cllr. M. Kennelly: That Kerry County Council open up the area servicing our Kerry County Council Listowel Library as this area is unutilised and serving no purpose.

1. Cllr. T. Barry: That Kerry County Council will engage further with our supermarkets, with a view to dealing with the issue of shopping trolleys that are being discarded in estates and laneways as it is clear that any previous efforts to resolve this issue have not worked.
