

Easy Guide to Making a Planning Application

1) Application Form fully completed as appropriate:

All questions answered and a signed application submitted 1 Original and 1 Copy

2) Planning Application Fee:

List of planning fees available.

3) Newspaper Notice in approved newspaper.

The Kerryman/Kerry's Eye/The Kingdom/Irish Examiner/Irish Independent/The Irish Daily Star/
The Irish Sun.

1 Entire page of Newspaper and 1 photocopy of entire page to be submitted

4) Site Notice in approved format.

Site notice to be left on site for a period of 5 weeks from the date the Planning Application was submitted to the planning authorities office. Copies available. 1 Original and 1 Copy

5) Site Location Map:

Scale of 1:1000 built up area and 1:2500 in all other. 6 No. Required

6) Site Layout Plan:

Scale of 1:500 6 No. Required

7) Floor Plans, Elevations and Sections:

Scale not less than 1:200 or other scale as agreed with the Planning authority prior to submission 6 No. Required

8) Disposal of Surface Water:

For development adjacent to/ exiting to a public road- Drawing to scale of the proposals with other appropriate details such as pipesizes, gradients, outfall points, gully locations etc.

9) Site Assessment/Percolation Test/Water Table Test:

Required for a site with a septic tank or wastewater treatment unit. A complete site assessment, completed in accordance with the E.P.A. Code of Practice (2009) is required.

Please note: Kerry County Council will only accept site assessments that have been carried out by a suitably qualified site assessor.

A complete site assessment will include...

A completed Site Characterisation Form in the standard E.P.A. Code of Practice format. The Site Characterisation Form can be downloaded from the E.P.A. website @

www.epa.ie/downloads/advice/water/wastewater

Various photographs, maps etc. of the site.

Detailed drawings of the proposed effluent treatment system including construction standard drawings.

The Site Characterisation process is a technically complex process which can only be carried out by appropriately trained and qualified assessors. A typical site assessment will take 4 – 5 working days to complete. 4 COLOUR copies.

10) Implementation of Housing Strategy:

Certificate of exemption must be applied for four houses or less. Otherwise Proposals need to be submitted for Five houses or More.

11) Supporting Documentation 2 no. copies

It is advised that you consult with the Planning Department prior to the submission of a planning application for a large scale development whether residential or industrial/commercial.
