Draft Dingle Electoral Area Local Area Plan

Notice is hereby given, pursuant to Section 20 of the Planning & Development Act 2000 - 2016 (as amended) that Kerry County Council, being the Planning Authority of the County of Kerry, has produced a Draft Local Area Plan for the An Daingean Electoral Area.

The Local Area Plan includes the settlements of Dingle/Daingean Uí Chúis, Annascaul, Baile an Fheirtéaraigh, Castlemaine, Castlegregory, Firies and Milltown and other small villages.

Invitation to make Submissions:

Submissions or observations on the Draft An Daingean Electoral Area Local Area Plan are hereby invited from members of the public and other interested parties. Children, or groups or associations representing the interests of children, are entitled to make submissions or observations.

The planning authority has prepared an environmental report of the likely significant effects on the environment of implementing the local area plan and that submissions or observations in respect of the environmental report made to the planning authority within the period specified in the notice will also be taken into consideration.

The Plan is also accompanied by a Habitats Directive Assessment Natura Impact Report which assesses the potential for impact on Natura 2000 sites and a Strategic Flood Risk Assessment Report.

Submissions may be made on the Draft Plan and/or the accompanying reports during the period from **Thursday 13th August 2020 until Friday 2nd October 2020**. Any submission on the Environmental Report, Natural Impact Report or Strategic Flood Risk Assessment should be clearly labelled as such.

Copies of the Draft An Daingean Electoral Area Local Area Plan, Strategic Environmental Assessment Environmental Report, Habitats Directive Assessment Natura Impact Report and the Strategic Flood Risk Assessment Report may be inspected **from Thursday 13th August 2020 until Friday 2nd October 2020 (both dates inclusive)** at the following locations:
