Finance (Local Property Tax) Regulations 2013 (S.I. 91 of 2013)

Dear Manager,

Further to Circular PS/LGFPT 2/2013, as issued on 20 March 2013, please find attached updated FAQ and link to your local authority's maps in respect of those unfinished housing developments qualifying for an exemption on the Local Property Tax.

The Finance (Local Property Tax) Regulations 2013 listed those developments qualifying for the exemption under Section 10 of the Finance (Local Property Tax) Act 2012.

You are asked to download your maps and to ensure that your local authority makes this information available to members of the public through your website and at public counters.
