Tugtar fógra anseo faoi réir Acht na mBóithre 1993, Alt 75, agus na Rialacha faoi Bóithre a Dhúnadh go Sealadach, 1994, go bhfuil Comhairle Contae Chiarraí **ag moladh** an bóthar, mar atá liostáilte thíos, a dhúnadh do thrácht poiblí, ar an **Luan 17ú Meán Fómhair go Máirt 18ú Meán Fómhair 2018**.

Notice is hereby given that, pursuant to Section 75 of the Roads Act 1993, and the Temporary Closing of Roads Regulations 1994, Kerry County Council **is proposing** to close to public traffic the following road from **Monday 17th September to Tuesday 18th September 2018**.

Bóthar a dhúnadh: Bóthar R560 ag An Tulaigh, Caisleán Ghriaire ó crosaire Cill Aighne go crosaire Árdán Uí Cheallaigh.

Road Closed: Road No. R560 at Tullig, Castlegregory from Killiney Cross to Kellyheight Cross.

Amannta Dúnta an Bhóthair: ó 9.30a.m. ar an Luan 17ú Meán Fómhair 2018 go 6.00p.m. ar an Máirt 18ú Meán Fómhair 2018, an dá dháta san aireamh.

Road Closing Times: from 9.30 a.m. on Monday 17th September 2018 to 6.00 p.m. on Tuesday 18th September 2018, both dates inclusive.

Tá an bóthar a dhúnadh ionas gur féidir íosbhealach do stoc a leagadh síos.

The purpose of the road closure is to facilitate the installation of a cattle underpass.

Beidh slí isteach ar fáil do sheirbhísí Éigeandála agus muintir na háite.

Access will be provided for Emergency Services and local residents.

Beidh malairt treo ar fáil tré Caisleán Ghriaire agus é seo marcála go soiléir.

Diversions will be in place through Castlegregory Village and will be signposted.
