COMPULSORY ACQUISITION OF LAND N69 LISTOWEL BYPASS ROAD IMPROVEMENT SCHEME COMPULSORY PURCHASE ORDER OF 2017

An Bord Pleanála has, on the 8th day of November, 2017, made a Confirmation Order confirming the above-named Compulsory Purchase Order as respects the land described in the Schedule hereto. The said order, as so confirmed, authorises Kerry County Council to acquire the said land compulsorily. It will become operative three weeks from the date of publication of this notice. A copy of the order as so confirmed and of the map referred to in it may be seen at all reasonable hours (being 9:00am to 5:00pm Monday to Friday, Bank Holidays excepted) at:

The order also authorises the local authority to extinguish the public right of way described in the Second Schedule hereto, by order made by them after they have acquired the said land.

An application for judicial review of the decision of the Board under Order 84 of the Rules of the Superior Courts (S.I. No. 15 of 1986) may be made to the High Court within eight weeks of the date of publication of this notice in accordance with Section 50 of the Planning and Development Act, 2000, as amended.
